

2008-09 HIGHLIGHTS

Results of Reading Initiative

Starting in January 2006, the Sun West School Division set a three-year goal that by June 2009, every student in the division would read at grade level or beyond, or at a level determined by their personal program plan or student support plan. To achieve this goal, over 100 teachers participated in committees that developed reading resources and strategies to help students, in every grade and in every subject area, improve their reading skills. DEAR (Drop Everything and Read) times were instituted in all Sun West schools, which encouraged students to read for pleasure.

Student reading assessments were on-going throughout the three years of the reading initiative. Assessments indicate that as of June 2009, 75.1% of Sun West students were reading at grade level or beyond or at the levels determined by their personal program plans or student support plans. Generally, student achievement in reading decreased as students progressed to higher grades. Sun West has now set a new three-year goal that permits schools to focus on one of three literacy areas; either reading, writing or mathematics. Schools select one area and work to improve achievement by one level in that area.

Distance Learning Centre Established at Kenaston School

Sun West's Distance Learning Centre at Kenaston School started operations in the fall of 2008. The Centre allows Sun West students access to classes that are not offered in their own schools. Some classes are provided through web-based technology such as SMART interactive whiteboards and Brigit conferencing software, while others are traditional print-based "correspondence" courses (which are no longer provided by the provincial government). Classes that have been offered by the Centre include: Physics, Chemistry, Calculus, Biology, Psychology, Math, Law and Information Processing.

Sun West and Great Plains Sign Memorandum of Understanding

In 2008, the Sun West School Division signed a memorandum of understanding with Great Plains College. The memorandum will provide Sun West and Great Plains opportunities to cooperate on projects of mutual interest. Sun West expects the partnership that develops from out of this memorandum will benefit Sun West students. Facilitating smooth transitions between high school graduation and post-secondary training and the work force is one of Sun West's priorities.

2008-09 HIGHLIGHTS

Sun West Graduation Rate Among the Best in Province

Final graduation statistics for 2008 from the Ministry of Education indicate that 93% of Sun West's grade 12 students obtained 24 or more credits and successfully completed their grade 12 year. The Sun West graduation rate was one of the highest in 2008 as well as one of the highest in the last five-year period. In addition, according to the Ministry of Education's provincial core indicators, Sun West had the lowest drop out rate in 2008 and provincial reading results place Sun West students second overall in reading among Saskatchewan school divisions.

New Elementary Report Card Piloted in 2008-09

A new Grades 1-5 report card was piloted in five Sun West schools during the 2008-09 school year. The new report card is consistent with the latest assessment research and provides parents and students with detailed information about student progress, including details of student learning behaviors. The report card was developed by a committee of teachers from the participating schools. Eventually report cards based on best assessment practices will be developed for all grades.

Student Leadership Conference Doubles Attendance

The Second Annual Sun West Student Leadership Conference held in April 2009 doubled its attendance to 160 students and teachers compared to only 80 who attended the first conference in April 2008. As well, 17 out of 17 Sun West schools with a grades 10-12 component attended the 2009 conference, compared to only 11 in 2008. The Conference was initiated in 2008 as part of the Board of Education's Student Leadership Program, which seeks to provide leadership opportunities to Sun West students.

Division Audits Now Include School Generated Funds

Starting with the 2008-09 fiscal year, the Ministry of Education is requiring School Divisions to follow Public Sector Accounting Board (PSAB) practices. As a result, revenues and expenses from school-based activities such as student clubs and fundraising must be reported in the Division audit.



MAP OF THE SUN WEST SCHOOL DIVISION





How Sun West Spends Education Dollars



Instruction (\$36,023,955): Textbooks, libraries, educational technology, extracurricular funding, salaries and benefits for teachers, educational assistants, superintendents and the Director of Education.

Plant (\$5,050,348): Heating, lighting, maintenance, repairs and improvements to division property, salaries and benefits for caretakers and maintenance personnel.

Transportation (\$4,828,584): Vehicle maintenance, fuel and new vehicle purchases, salaries and benefits for drivers and mechanics.

School Generated Funds (\$1,770,595): Expenses of school SRC/SLCs and other school-based activities.

Administration (\$883,941): Division Office expenses including building and staff costs.

Other (1%): Governance (\$314,654), Tuition and Related Fees (\$53,738), Interest and Bank Charges (\$5,863) and External Services (\$629).

In coming years, Boards of Education, Division employees and SCCs must work together, as never before, to ensure the provincial government recognizes the value of grades K-12 education and funds it accordingly.
